Support persons

A support person is only permitted to accompany a patient to ambulatory care appointments and to the emergency room in certain circumstances, including if the patient:

- has trouble understanding what might be said;
- requires assistance with decision-making;
- requires assistance with mobility;
- · requires assistance due to significant behavioral symptoms; or
- has a reasonable expectation of receiving information which may have significant implications for their future health.

If a support person is permitted to attend an appointment, the support person must always stay with the patient.

Support persons are not permitted to go to the cafeteria to wait for the patient. If the support person is not deemed necessary, they should leave the building. For full details on visitor restrictions at all Eastern Health facilities, please see: www.easternhealth.ca/covid19.
