
RE: Changes to the Order Entry (OE) effective March 31st, 2021

The Eastern Health-Labrador Grenfell Health Meditech system is influenced by many factors, consolidation progress, practice changes, issues with functionality and user feedback. As a result, changes to the modules within Meditech will be necessary at times.

The ordering process for COVID-19 testing has been updated provincially as per requests/guidelines.

The COVID19 test has been added to the procedure **RESVIP – RESPIRATORY VIRUS PANEL**, so any testing for Covid will be done when this procedure is ordered. The COVID19 procedure will be inactivated, and you will NOT be able to order COVID19 anymore! Instead order **RESVIP** and the Covid test will be resulted with the RESVIP procedure.

The RESVIP procedure can be ordered by itself to test for the coronavirus, as well as to test for additional respiratory viruses. The current questions that are answered for the COVID19 procedure will now be required for the RESVIP procedure; along with one additional question - Patient Status, see below:



Outpatients Only:


The **COVID19POC** procedure for **Point of Care/Rapid testing** is still available for use for **outpatients only**. Staff using this procedure are aware of when to order this procedure for Covid testing. There are no changes to this procedure. Continue to order the point of care COVID procedure as directed, as well as the RESVIP procedure at the same time.

LGH Only:

For Labrador Grenfell Health (LGH) the **COVID19R – CORONAVIRUS;NOVEL 2019 R (LGH)** procedure will be available for specific testing criteria for LGH sites only. Areas requiring this procedure are aware of the circumstances in which it should be ordered.

If ordered from an EH site you will get a popup, not orderable from that site/campus, see below. You will not get a popup when ordering from a LGH site and will be able to proceed and file the order.

POM users will now be required to answer the questions on the **RESVIP** procedure when ordering for inpatients, in accordance with government guidelines.
