## St. Clare's Mercy Hospital - COVID-19 Cases

- Following the first positive case reported on February 8, 2021, testing and investigation has been ongoing which has resulted in the identification of an additional small number of positive cases on a unit at St. Clare's Mercy Hospital.
- A Rapid Response Team has been deployed to St. Clare's Mercy Hospital and testing of affected
  patients and staff is underway. All positive patients on the unit have been transferred to the
  COVID-19 Unit at the Health Sciences Centre. All other patients on the unit have been put on
  strict isolation precautions and transferred to single rooms. The unit is closed to new admissions
  at this time and staff movement is limited in and out of the area. For full details, please see our

 We appreciate the enormous efforts that our staff and physicians are taking to keep patients, employees and their families safe. We'd like to reassure you that we have number of infection prevention and control, occupational health and public health measures in place to limit the spread of the COVID-19 virus in this unit.

### **Occupational Health & Safety**

- St. Clare's Mercy Hospital Contact tracing is underway and Occupational Health is reaching out to employees who are close contacts of the affected individuals at St. Clare's Mercy Hospital and will provide further guidance on testing and isolation in collaboration with the Medical Officer of Health for their plan of care and whether additional swabbing may be required.

- PPE Staff and physicians are reminded of the critical importance of wearing appropriate
  personal protective equipment. Please use the <u>Point of Care Risk Assessment (PCRA)</u> to
  determine the appropriate PPE for each client encounter.
- **Accommodations support** If you require assistance and support while you are required to self-isolate, please contact the Employee & Physician Navigation line at 709-752-3663.
- Staff who are isolating as a result of public health/occupational health direction are required to receive **clearance** from Occupational Health **prior to returning to work**. #### Update on latex content in front-line shields

Supplier DF Barnes recently reviewed all aspects of the supply chain for front-line shields and reported to Eastern Health that no latex was used in the manufacture, assembly or packaging of their shields. The cause of confusion stemmed from a misunderstanding of labelling requirements which resulted in it being unclear if the product/packaging contained latex.

The manufacturer would like to assure Eastern Health that the front-line shields are 100% latex free and apologizes for any confusion or anxiety this may have caused.
