Step 1: Accessing HEALTHe NL

- Access HEALTHe NL via <https://healthnl.ca>
- Enter your username
- Enter your password
- Click **Login**

HEALTHe NL is the Province's electronic health record, and as such, it provides additional information to you at the point of care. HEALTHe NL consolidates information from a variety of source systems across the province. While continuing efforts are applied to ensure accuracy and completeness, HEALTHe NL is not an exhaustive source of information. Patient data may exist in other RHAs, community health, private clinics or pharmacy databases. All pharmacies in the province are now connected to the Pharmacy Network.
